A submission is to include the following in addition to this completed and signed document. No incomplete submissions will be recorded for review. Please allow up to two weeks for response.

TECHNICAL REQUIREMENTS-

Story title and synopsis (one over all story synopsis plus an individual per volume proposed if title is a series)

Text & graphic character description sheet with both black and white toned versions of the characters in addition to color versions.

8-10 completed manga pages (this means print ready art that has been inked and toned with type set) submitted in a PSD and PDF format. 2 files per page are required, the first being a completed image including the text layer; the second being just the image file without the text layer. Resolution for all print ready art is to be at least 300 DPI. Page dimensions are: 4.5" x 7" INCLUDING a .25" bleed. All text must be set within the "live area" (inside the main area not including the bleed)

Submission is to include this contact sheet and resume for the property owner. Publisher agrees not to distribute the personal or professional contact information provided by the property owner to any outside sources beyond this intended submission request.
